Smart phone callers may be able to participate by using the "raise hand" function. Land line callers will be able to listen, but not participate. All callers, or viewers may participate and provide public comment by using a designated email indicated below.

 - b. Do not use speakerphone;
 - c. Do not use Bluetooth devices;
 - d. Mute all background noise;
 - e. Mute the livestream feed and/or the Channel 18 and use only the telephone audio;
 - f. Please do not speak until the chair or the meeting moderator asks for public comments or questions.

No in-person attendance of members of the public will be permitted. The measures state above follow the emergency order of the Governor for remote participation. Meetings will be broadcast on Channel 18 as soon as possible after the close of the meeting.
