In the event that we are unable to do so, despite best efforts, we will post on the town's website an audio or video recording, transcript, or other comprehensive record of proceedings as soon as possible after the meeting.

- Attendees will be called upon by the Chair to speak. Attendees can use the "Raise Hand" button to identify themselves (all participants will be muted, you must be recognized by the chair to participate).
- To attend the meeting by dial-in phone, call +1 301 715 8592 and enter meeting ID 849 0356 7106. The dial-in number can also be used to access the audio while watching the online meeting (if you don't have speakers and/or a microphone).
- Dial in attendants should press *9 to notify the chair of their presence when called upon. The meeting host will un-mute attendees when they are called upon to speak.
